## NOTICE OF NON-STREAMLINED DOMESTIC SECTION 214 APPLICATIONS GRANTED

## WC Docket Nos. 10-201 and 10-202

Pursuant to section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and sections 0.91, 0.291, and 63.03 of the Commission's rules, 47 C.F.R. §§ 0.91, 0.291, and 63.03, the Wireline Competition Bureau (Bureau) approves the applications of Redwood County Telephone Company (Redwood), and its wholly owned subsidiary, Redwood Long Distance Company (Redwood LD), Clements Telephone Company (Clements), and Arvig Enterprises, Inc. (Arvig) to transfer the assets of Redwood and Redwood LD to Arvig and to transfer control of Clements of Arvig. No commenter opposed grant of either application.
