Re: Petition for Reconsideration of Dismissal of Application File No. 0004450126

Dear Mr. Lidikay:

This letter addresses your petition for reconsideration of the dismissal of the above-referenced application, filed November 12, 2010, for a new trunked Industrial/Business Pool station on 470-512 MHz band (T-band) frequencies in Chicago. For the reasons set forth below, the petition is denied.

T-band frequencies are not reassigned within forty miles of a fully loaded co-channel station.<sup>2</sup> Your application was dismissed on November 16, 2010, because Laing Electronics's Station WQLA270, Chicago, Illinois, was fully loaded on the requested frequencies.<sup>3</sup> On the same day, Laing Electronics filed an application to cancel the license for Station WQLA270, which was granted the next day.<sup>4</sup>

You argue that the dismissal of your application was erroneous because the license for Station WQLA270 was canceled before the application was dismissed.<sup>5</sup> As noted above, however, your application was dismissed on November 16, 2010, but the license for Station WQLA270 was canceled on November 17, 2010. Consequently, we conclude that your application was properly dismissed.<sup>6</sup>
