The Wireline Competition Bureau seeks comment on an appeal filed by the East Ascension Telephone Company LLC and EATELCORP, INC. of a decision by the Universal Service Administrative Company concerning a performance audit conducted by KPMG LLP regarding universal service fund disbursements made to EATEL during the twelve-month period ending June 30, 2007.¹

Interested parties may file **comments on or before January 4, 2011**, and **reply comments on or before January 19, 2011**. All pleadings are to reference **WC Docket No. 08-71**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.²

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.³ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁴ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁵
