## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON TRACFONE PETITION FOR DECLARATORY RULING ON UNIVERSAL SERVICE ISSUES

WC Docket Nos. 09-197, 03-109

The Wireline Competition Bureau seeks comment on a petition for a declaratory ruling filed on December 1, 2010, by TracFone Wireless, Inc. (TracFone).<sup>1</sup> Specifically, TracFone seeks a declaratory ruling regarding the Link Up support eligible telecommunications carriers (ETCs) may receive, the designation of wireless ETCs, and the requirement that ETCs offer service using their own facilities.<sup>2</sup>

Interested parties may file **comments on or before December 23, 2010**, and **reply comments on or before January 10, 2011**. All pleadings are to reference **WC Docket Nos. 09-197 and 03-109**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>3</sup>

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- **Paper Filers:** Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>6</sup>
