## COMMENTS INVITED ON APPLICATION OF FIRST COMMUNICATIONS, LLC TO DISCONTINUE DOMESTIC TELECOMMUNICATIONS SERVICES

WC Docket No. 10-259 Comp. Pol. File No. 966

Comments Due: January 7, 2011

**Section 214 Application** 

**Applicant: First Communications, LLC** 

On **December 3, 2010, First Communications, LLC** (First Communications or Applicant), located at **3340 West Market Street, Akron, Ohio 44333**, filed an application with the Federal Communications Commission (FCC or Commission) requesting authority, under section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue the provision of certain domestic telecommunications services in Massachusetts and New York.

First Communications indicates that it currently provides local exchange services to a total of 233 customers served by certain central offices in Massachusetts and New York (Service Areas). First Communications specifies that it provides these local exchange services to 115 customers in Massachusetts and 118 customers in New York, by purchasing Wholesale Advantage, formerly UNE-P, which includes a complete platform of network elements from Verizon. First Communications, however, states that it now plans to discontinue services to all of these affected customers on January 31, 2011. First Communications maintains that the impact on the public should be minimal due to the small number of customers that will be affected by the proposed discontinuance, and states that it will continue to provide telecommunications services in other areas of Massachusetts and New York apart from the affected central offices. First Communications indicates that it mailed notice of the proposed discontinuance to all affected customers via first class U.S. Mail in accordance with the requirements of section 63.71(a) of the Commission's rules on or before November 30, 2010. First Communications states that it is considered non-dominant with respect to the services to be discontinued.

In accordance with section 63.71(c) of the Commission's rules, First Communications' application will be deemed to be granted automatically on the 31st day after the release date of this public notice, unless the Commission notifies First Communications that the grant will not be automatically effective. In its application and notice to customers, First Communications indicates that it anticipates discontinuing service on January 31, 2011, subject to regulatory approval. Accordingly, pursuant to section 63.71(c), absent further Commission action, First Communications may terminate the affected services in the Service Areas on or after **January 31, 2011**. The Commission normally will authorize proposed discontinuances of service unless it is shown that customers or other end users would be unable to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

This proceeding is considered a "permit but disclose" proceeding for purposes of the Commission's ex parte rules, 47 C.F.R. §§ 1.1200-1.1216. Comments objecting to this application must be filed with the Commission on or before **January 7, 2011**. Such comments should refer to **WC Docket No. 10-259 and Comp. Pol. File No. 966**. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <a href="http://www.fcc.gov/cgb/ecfs/">http://www.fcc.gov/cgb/ecfs/</a>.
