## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON OREGON HEALTH NETWORK REQUEST FOR ADDITIONAL FUNDING UNDER THE RURAL HEALTH CARE PILOT PROGRAM

The Wireline Competition Bureau (Bureau) seeks comment on a request filed by the Oregon Health Network (OHN) for additional funding under the Rural Health Care Pilot Program (Pilot Program).<sup>1</sup> In the 2007 Pilot Program Selection Order, the Commission selected 69 projects to participate in the Pilot Program.<sup>2</sup> The Commission provided a maximum funding amount of \$417 million for all program participants,<sup>3</sup> and also established per-project maximum support amounts.<sup>4</sup>

OHN requests that, in the event that the Pilot Program funds allotted in the 2007 Pilot Program Selection Order are unused or relinquished by other participants, the Bureau increase OHN's maximum support amount by an additional \$46.2 million.<sup>5</sup> If additional funding is authorized, OHN requests an extension of time for the project to secure funding commitments and complete invoicing.<sup>6</sup>

Interested parties may file comments on or before **January 27, 2011**, and reply comments on or before **February 11, 2011**. All pleadings are to reference **WC Docket No. 02-60**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>7</sup>

More than a one or two sentence description of the views and
