**PLEADING CYCLE ESTABLISHED FOR UNITED STATES TELECOM ASSOCIATION  
PETITION FOR WAIVER OF REQUIREMENTS IN SECTION 61.49(K) OF THE  
COMMISSION'S RULES FOR THE SHORT FORM TARIFF REVIEW PLAN**

On February 4, 2010, the United States Telecom Association (USTelecom) filed a petition on behalf of its price cap members seeking a permanent waiver of requirements in section 61.49(k) of the Commission's rules regarding non-exogenous cost data filing requirements for the Short Form Tariff Review Plan (TRP).<sup>1</sup> Specifically, USTelecom requests that all price cap LECs receive a waiver from the requirement that they submit PC-1 and IND-1 forms as part of the Short Form TRP.<sup>2</sup> USTelecom also requests that price cap LECs that have reached their Average Traffic Sensitive (ATS) rate target receive a waiver from the requirement that they submit the TGT-1 and TGT-2 forms as part of the Short Form TRP.<sup>3</sup> In addition, USTelecom requests that the deadline for the Short Form TRP be moved to May 17 to give price cap carriers additional time to prepare their cost data.<sup>4</sup>

Interested parties may file comments on the USTelecom Petition on or before **March 5, 2010** and reply comments on or before **March 12, 2010**. Filings in this proceeding should be captioned "USTelecom Petition for Waiver of Section 61.49(k)" and filed in WC Docket No. 10-46.

Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.

This Public Notice establishes certain procedural requirements relating to consideration of the petition for preemption. This matter shall be treated as a "permit-but-disclose" proceeding in accordance

with the Commission's *ex parte* rules.<sup>5</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and arguments presented generally is required.<sup>6</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>7</sup>
