## NOTICE OF NON-STREAMLINED DOMESTIC SECTION 214 APPLICATION GRANTED

Pursuant to section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and sections 0.91, 0.291, and 63.03 of the Commission's rules, 47 C.F.R. §§ 0.91, 0.291, and 63.03, the Wireline Competition Bureau (Bureau) approves the application of Prairie Telephone Co., Inc. d/b/a Western Iowa Networks (Prairie) and Panora Communications Cooperative (PCC) to transfer a portion of Prairie's Yale, Iowa local telephone exchange to PCC. No commenter opposed grant of the application.
