COMMENT SOUGHT ON PETITION OF AD HOC COALITION OF INTERNATIONAL TELECOMMUNICATIONS COMPANIES FOR RULEMAKING REGARDING THE REPORTING OF WHOLESALE REVENUES FOR PURPOSES OF UNIVERSAL SERVICE CONTRIBUTION ASSESSMENT

The Ad Hoc Coalition of International Telecommunications Companies (Coalition) filed a petition on February 16, 2010, requesting that the Commission commence a rulemaking to address the Universal Service Administrative Company's interpretation and application of the rules and requirements for carriers' reporting of revenues from the provision of service to other carriers (i.e., wholesale revenues) for purposes of determining universal service contribution obligations. The Coalition asks that "the Commission suspend all pending and future enforcement" of these rules and requirements as currently interpreted until new rules are adopted.<sup>2</sup>

Interested parties may file comments on or before March 29, 2010, and reply comments on or before April 13, 2010. All pleadings are to reference WC Docket No. 06-122. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>3</sup>
