**COMMENT SOUGHT ON PETITION OF VIRGIN MOBILE FOR  
LIMITED DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER  
IN CONNECTICUT, DELAWARE, NEW HAMPSHIRE, AND THE DISTRICT OF COLUMBIA**

The Wireline Competition Bureau seeks comment on four petitions filed February 17, 2010, by Virgin Mobile USA, L.P. (Virgin Mobile), a provider of commercial mobile radio services.<sup>1</sup> Virgin Mobile seeks designation as an eligible telecommunications carrier (ETC) in the states of Connecticut, Delaware, and New Hampshire and the District of Columbia.<sup>2</sup> Virgin Mobile seeks ETC designation for the limited purpose of participating in the universal service low-income Lifeline program and does not request ETC designation to receive universal service high-cost support.<sup>3</sup>

Interested parties may file **comments on or before March 29, 2010**, and **reply comments on or before April 13, 2010**. All pleadings are to reference **WC Docket No. 09-197**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>4</sup>

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>5</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>6</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>7</sup>
