## COMMENT SOUGHT ON THE PETITION OF COLORADO E-911 AUTHORITIES TO REJECT TRACFONE WIRELESS'S SELF-CERTIFICATION OF 911 AND E-911 COMPLIANCE

The Wireline Competition Bureau seeks comment on a petition filed by the Adams County E-911 Emergency Telephone Service Authority, the Arapahoe County E-911 Emergency Communication Service Authority, and the Jefferson County Emergency Communications Authority (collectively, the Colorado 911 Authorities).<sup>1</sup> The Colorado 911 Authorities maintain that TracFone Wireless, Inc. (TracFone) is not in compliance with 911 and E-911 requirements in the state of Colorado and request that the Commission reject TracFone's self-certification until TracFone is in compliance with Colorado 911 funding laws.<sup>2</sup> The Colorado 911 Authorities further request that the Commission compel TracFone

to comply with Colorado law relating to 911 funding and to deny or invalidate TracFone's self-certification pending TracFone's compliance with this law.<sup>3</sup>

Interested parties may file **comments on or before March 31, 2010**, and **reply comments on or before April 15, 2010**. All pleadings are to reference **WC Docket No. 09-197**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>4</sup>
