COMMENTS INVITED ON APPLICATION OF COMCAST PHONE OF NORTHERN VIRGINIA, INC. D/B/A COMCAST DIGITAL PHONE OF NORTHERN VIRGINIA TO DISCONTINUE DOMESTIC TELECOMMUNICATIONS SERVICES

Section 214 Application

Applicant: Comcast Phone of Northern Virginia, Inc. d/b/a Comcast Digital Phone of Northern Virginia

On **February 1, 2010**, **Comcast Phone of Northern Virginia, Inc. d/b/a Comcast Digital Phone of Northern Virginia** (Comcast or Applicant), located at **One Comcast Center, 50th Floor, Philadelphia, PA 19103**, filed an application with the Federal Communications Commission (FCC or Commission) requesting authority, under section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue the provision of certain domestic telecommunications services in Virginia.

Comcast indicates that it currently provides interstate and intrastate telecommunications services throughout Virginia. Comcast states, however, that it now intends to discontinue its provision of certain telecommunications services, offered to the public under the brand name "Comcast Digital Phone," in Northern Virginia. According to Comcast, the anticipated date for the proposed discontinuance is March 31, 2010, or as soon thereafter as the necessary state and federal approvals can be obtained. Comcast explains that the proposed March 31, 2010 disconnection will be a "soft disconnect" and that customers in the affected location will continue to be able to call emergency services by dialing 911, and to call the Comcast Phone call center until April 30, 2010, or one month after the authorized disconnection date. Comcast states that it will assist affected customers during their transition to alternative service providers, and that it will continue to provide other telecommunications services in Virginia. Comcast indicates that it informed all affected customers of the proposed discontinuance by letters sent via first class U.S. Mail on January 30, 2010. Comcast asserts that it is non-dominant in the local exchange, interstate, and interexchange services markets.

In accordance with section 63.71(c) of the Commission's rules, Comcast's application will be deemed to be granted automatically on the 31st day after the release date of this public notice, unless the Commission notifies Comcast that the grant will not be automatically effective. In its application and notice to customers, Comcast indicates that it anticipates discontinuing service on or after March 31, 2010, subject to regulatory approval. Accordingly, pursuant to section 63.71(c) and the terms of Comcast's application and notice, absent further Commission action, Comcast may terminate its Comcast Digital Phone service in Northern Virginia on or after **March 31, 2010**. The Commission normally will

authorize proposed discontinuances of service unless it is shown that customers or other end users would be unable to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

This proceeding is considered a “permit but disclose” proceeding for purposes of the Commission’s ex parte rules, 47 C.F.R. §§ 1.1200-1.1216. Comments objecting to this application must be filed with the Commission on or before **March 15, 2010**. Such comments should refer to **WC Docket No. 10-50 and Comp. Pol. File No. 929**. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. Comments may be filed using the Commission’s Electronic Comment Filing System (ECFS) or by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <http://www.fcc.gov/cgb/ecfs/>. Filers should follow the instructions provided on the Web site for submitting comments. Generally, only one copy of an electronic submission must be filed. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, filers should send an e-mail to ecfs@fcc.gov, and include the following words in the body of the message, “get form.” A sample form and directions will be sent in response.

Parties who choose to file by paper must send an original and four copies of the comments to the Office of the Secretary, Federal Communications Commission, 445 12th Street, S.W., Room TW-A325, Washington, D.C. 20554. Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail.
