MEDIA BUREAU SEEKS COMMENT ON A PETITION PURSUANT TO THE COMMISSION'S OVER-THE-AIR RECEPTION DEVICES RULE REQUESTING WAIVER OF THE 1 METER SIZE LIMITATION IN HAWAII AND A DECLARATORY RULING THAT THE ANTENNA RESTRICTIONS OF A HOMEOWNERS ASSOCIATION ARE PREEMPTED

Policarpio Medios (“Petitioner”) has filed a Petition for Waiver and Declaratory Ruling on behalf of tenants renting his home in Waipahu, Hawaii. First, Petitioner requests a waiver of the coverage limitation of the Commission’s Over-the-Air Reception Devices Rule (“OTARD”) for satellite dish antennas located in Hawaii. The OTARD rule covers antennas that measure one meter or less or any size if they are located in Alaska. Petitioner states that to receive signals from at least one satellite service provider in Hawaii, an antenna of 1.2 meters is required. He asks that antennas larger than one meter in Hawaii be protected by OTARD.

Petitioner also requests a Declaratory Ruling that the antenna installation rules of Gentry Waipio Community Association (“Association”) are preempted by Section 1.4000 of the Commission’s rules. According to the Petition, the Association’s rules require prior approval of antenna installations. This Public Notice announces the pleading cycle for this Petition during which responses and replies may be filed.

This proceeding will be treated as “permit but disclose” for purposes of the Commission’s *ex parte* rules. See generally 47 C.F.R. §§ 1.1200-1.1216. As a result of the permit-but-disclose status of this proceeding, *ex parte* presentations will be governed by the procedures set forth in Section 1.1206 of the Commission’s rules applicable to non-restricted proceedings.¹

Parties may file responses to the Petition on or before April 8, 2010 and replies on or before April 23, 2010. Please place the case identifier, **CSR-8302-O**, on all filings. One copy of responses, replies, or other communications must be served on all participants in the case.

Parties must file an original and two copies of each filing. Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail.
