## PLEADING CYCLE ESTABLISHED FOR COMMENTS ON WINDSTREAM PETITION FOR LIMITED WAIVER RELIEF

WC Docket No. 10-55

COMMENTS DUE: March 24, 2010 REPLY COMMENTS DUE: April 5, 2010

On March 2, 2010, Windstream Corporation (Windstream) petitioned the Commission to allow its newly acquired subsidiary, Lexcom, to convert from rate-of-return regulation to price cap regulation. Specifically, Windstream requests the "necessary waiver relief on an expedited basis to enable Windstream to apply to Lexcom the universal service mechanism governing the rest of Windstream's LECs converted to price cap regulation under the *Windstream Order*." Windstream argues that such uniformity of regulatory treatment would "advance the public interest benefits of the *Windstream Order*" and that a grant of the requested relief "will increase consumer welfare by reducing the overall size of the universal service fund ('USF') and enabling Windstream to maintain and enhance efficient operations and thereby generate all of the competitive benefits of converting Lexcom to price cap regulation."

Interested parties may file comments on the Windstream Petition on or before **March 24, 2010** and reply comments on or before **April 5, 2010**. Filings in this proceeding should be captioned "Windstream Petition for Limited Waiver Relief" and filed in WC Docket No. 10-55.

Commission's *ex parte* rules.<sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one- or two-sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>6</sup>
