## DOMESTIC SECTION 214 AUTHORIZATION GRANTED

Application Filed for the Transfer of Control of Total Call International, Inc. to KDDI America, Inc.

## WC Docket No. 09-228

## By the Chief, Wireline Competition Bureau:

On December 11, 2009, Total Call International, Inc. (Total Call) and KDDI America, Inc. (KDDI America) (together, Applicants) filed an application pursuant to section 63.03 of the Commission's rules seeking approval for the transfer of control of Total Call to KDDI America.<sup>1</sup>

The Commission released a public notice accepting the application for streamlined processing on December 22, 2009.<sup>2</sup> On January 4, 2010, the Department of Justice, including the Federal Bureau of Investigation, with the concurrence of the Department of Homeland Security (collectively, the Executive Branch Agencies), filed a letter requesting that the Commission defer grant of this application while they addressed potential national security, law enforcement, and public safety issues.<sup>3</sup> On January 14, 2010, the Commission released a public notice removing the application from streamlined treatment.<sup>4</sup> On March 15, 2010, the Executive Branch Agencies withdrew their January 4, 2010 request to defer action, stating that they have no comment on this transaction.<sup>5</sup>

The Wireline Competition Bureau finds, upon consideration of the record, that grant of the application will serve the public interest, convenience, and necessity. Upon consummation of the reorganization, the resulting entity will have a market share in the U.S. interstate interexchange market of less than 10 percent, and will provide competitive telephone exchange services or exchange access services (if at all) exclusively in geographic areas served by a dominant local exchange carrier in the U.S.

that is not a party to the transaction. In addition, the Applicants will not be dominant with respect to any domestic service.<sup>6</sup>

Consistent with Commission precedent, the Wireline Competition Bureau accords the appropriate level of deference to the Executive Branch Agencies' expertise on national security and law enforcement issues.<sup>7</sup> Therefore, pursuant to section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and section 0.291 of the Commission's rules, 47 C.F.R. § 0.291, the Wireline Competition Bureau hereby grants the application discussed in this Public Notice.

Pursuant to section 1.103 of the Commission's rules, 47 C.F.R. § 1.103, the grant is effective upon release of this Public Notice. Petitions for reconsideration under section 1.106 or applications for review under section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the date of this Public Notice.
