COMMENT SOUGHT ON THE PINE BELT TELEPHONE COMPANY, INC. PETITION FOR DECLARATORY RULING OR WAIVER OF NATIONAL EXCHANGE CARRIER ASSOCIATION, INC. REQUIREMENTS

The Wireline Competition Bureau seeks comment on a petition filed by Pine Belt Telephone Company, Inc. (Pine Belt) asking the Commission to: (1) direct the National Exchange Carrier Association, Inc. (NECA) to re-open the 24-month window that NECA established for its members to adjust cost studies submitted to NECA so that Pine Belt may adjust its 2005 cost study; and (2) require that NECA reimburse Pine Belt for any amounts that may become due to Pine Belt as a result of Pine Belt's desired adjustments.¹

Interested parties may file **comments on or before February 11, 2010**, and **reply comments on or before February 26, 2010**. All pleadings are to reference **WC Docket No. 08-71**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.²

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.³ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁴ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁵
