## COMMENT SOUGHT ON THE PETITION OF PARTNER COMMUNICATIONS COOPERATIVE FOR FORBEARANCE FROM SECTION 54.305(b) and (d) OF THE COMMISSION'S UNIVERSAL SERVICE HIGH-COST SUPPORT RULES

On December 2, 2009, Partner Communications Cooperative (Partner), pursuant to section 10 of the Communications Act of 1934, as amended, filed a petition for forbearance from section 54.305(b) and (d) of the Commission's rules.<sup>1</sup> Specifically, Partner requests that the Commission forbear from enforcing section 54.305(b) and (d) of the Commission's rules so that Partner may receive additional universal service high-cost support and local switching support for four exchanges it acquired in 2006.<sup>2</sup> Partner states that grant of its petition will allow Partner to upgrade its telephone network and provide the platform for eventual ubiquitous broadband coverage in the four acquired high-cost exchanges, as well as in its two original exchanges.<sup>3</sup> The Wireline Competition Bureau seeks comment on Partner's petition.

Interested parties may file **comments on or before February 11, 2010 and reply comments on or before February 26, 2010**. All pleadings are to reference **WC Docket No. 05-337**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>4</sup>

More than a one or two sentence description of the views and arguments presented generally is required.<sup>6</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>7</sup>
