The Wireline Competition Bureau seeks comment on a petition filed December 30, 2009, by Consumer Cellular, Inc. (Consumer Cellular), a reseller of commercial mobile radio services. Consumer Cellular seeks designation as an eligible telecommunications carrier (ETC) for certain counties in Connecticut, New York, North Carolina, Tennessee, and Virginia. Consumer Cellular seeks ETC designation for the limited purpose of participating in the universal service low-income Lifeline program and does not request ETC designation to receive high-cost universal service support.

Interested parties may file **comments on or before February 11, 2010**, and **reply comments on or before February 26, 2010**. All pleadings are to reference **WC Docket No. 09-197**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.⁴
