## COMMENT SOUGHT ON ALLIED WIRELESS COMMUNICATIONS PETITION FOR ELIGIBLE TELECOMMUNICATIONS CARRIER DESIGNATION IN NORTH CAROLINA

**WC Docket No. 09-197**

On April 13, 2010, Allied Wireless Communications Corporation (AWCC) filed a petition seeking designation as an eligible telecommunications carrier (ETC) in North Carolina pursuant to section 214(e)(6) of the Communications Act of 1934, as amended. AWCC states that its petition addresses the ETC component of a pending transaction in which AWCC proposes to purchase certain markets divested as a result of the Verizon Wireless and Alltel merger.<sup>2</sup>

Interested parties may file **comments on or before April 30, 2010** and **reply comments on or before May 7, 2010.** All pleadings are to reference **WC Docket No. 09-197**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>3</sup>

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>6</sup>
