ORDER

By the Deputy Chief, Consumer Policy Division, Consumer & Governmental Affairs Bureau:

1. In this Order, we consider the complaint filed by Complainant¹ alleging that National Access Long Distance, Inc. (NALD) changed Complainant's telecommunications service provider without obtaining authorization and verification from Complainant in violation of the Commission's rules.² We conclude that NALD's actions did result in an unauthorized change in Complainant's telecommunications service provider and we grant Complainant's complaint.

2. In December 1998, the Commission released the *Section 258 Order* in which it adopted rules to implement Section 258 of the Communications Act of 1934 (Act), as amended by the Telecommunications Act of 1996 (1996 Act).³ Section 258 prohibits the practice of

“slamming,” the submission or execution of an unauthorized change in a subscriber’s selection of a provider of telephone exchange service or telephone toll service.⁴ In the *Section 258 Order*, the Commission adopted aggressive new rules designed to take the profit out of slamming, broadened the scope of the slamming rules to encompass all carriers, and modified its existing requirements for the authorization and verification of preferred carrier changes. The rules require, among other things, that a carrier receive individual subscriber consent before a carrier change may occur.⁵ Pursuant to Section 258, carriers are absolutely barred from changing a customer's preferred local or long distance carrier without first complying with one of the Commission's verification procedures.⁶ Specifically, a carrier must: (1) obtain the subscriber's written or electronically signed authorization in a format that meets the requirements of Section 64.1130 ; (2) obtain confirmation from the subscriber via a toll-free number provided exclusively for the purpose of confirming orders electronically; or (3) utilize an independent third party to verify the subscriber's order.⁷

3. The Commission also has adopted liability rules. These rules require the carrier to absolve the subscriber where the subscriber has not paid his or her bill. In that context, if the subscriber has not already paid charges to the unauthorized carrier, the subscriber is absolved of liability for charges imposed by the unauthorized carrier for service provided during the first 30 days after the unauthorized change.⁸ Where the subscriber has paid charges to the unauthorized carrier, the Commission’s rules require that the unauthorized carrier pay 150% of those charges to the authorized carrier, and the authorized carrier shall refund or credit to the subscriber 50% of all charges paid by the subscriber to the unauthorized carrier.⁹ Carriers should note that our actions in this order do not preclude the Commission from taking additional action, if warranted, pursuant to Section 503 of the Act.¹⁰

4. We received Complainant’s complaint on October 14, 2009, alleging that Complainant’s telecommunications service provider had been changed to NALD without Complainant’s authorization. Pursuant to Sections 1.719 and 64.1150 of our rules,¹¹ we notified

NALD of the complaint and NALD responded on November 7, 2009.¹² NALD states that authorization was received and confirmed through third party verification (TPV). We have reviewed the TPV that NALD filed with its response. NALD's verifier stated that the purpose of the recorded conversation was to "verify and confirm your account information." However, the purpose of a TPV recording is to verify a subscriber's intent to change their preferred carrier. As we emphasized in the *Fourth Report and Order*, "any description of the carrier change transaction...shall not be misleading."¹³ We find that NALD actions were in violation of our carrier change rules, and we discuss NALD's liability below.¹⁴

5. Pursuant to Section 64.1170(b) our rules, NALD must forward to AT&T an amount equal to 150% of all charges paid by the subscriber to NALD along with copies of any telephone bills issued from NALD to the Complainant.¹⁵ Within ten days of receipt of this amount, AT&T shall provide a refund or credit to Complainant in the amount of 50% of all charges paid by Complainant to NALD. Complainant has the option of asking AT&T to re-rate NALD charges based on AT&T rates and, on behalf of Complainant, seek from NALD, any re-rated amount exceeding 50% of all charges paid by Complainant to NALD. AT&T must also send a notice to the Commission, referencing this Order, stating that it has given a refund or credit to Complainant.¹⁶ If AT&T has not received the reimbursement required from NALD within 45 days of the release of this Order, AT&T must notify the Commission and Complainant accordingly. AT&T also must notify the Complainant of his or her right to pursue a claim against NALD for a refund of all charges paid to NALD.¹⁷

6. Accordingly, IT IS ORDERED that, pursuant to Section 258 of the Communications Act of 1934, as amended, 47 U.S.C. § 258, and Sections 0.141, 0.361 and 1.719 of the Commission's rules, 47 C.F.R. §§ 0.141, 0.361, 1.719, the complaint filed by Complainant against NALD IS GRANTED.

7. IT IS FURTHER ORDERED that, pursuant to Section 64.1170(d) of the Commission's rules, 47 C.F.R. § 64.1170(d), Complainant is entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred and neither NALD nor AT&T may pursue any collection against Complainant for those charges.
