ORDER

By the Deputy Chief, Consumer Policy Division, Consumer & Governmental Affairs Bureau:

- 1. In this Order, we consider the complaint¹ alleging that Multiline Long Distance (MLD) changed Complainant's telecommunications service provider without obtaining authorization and verification from Complainant in violation of the Commission's rules.² We conclude that MLD's actions did result in an unauthorized change in Complainant's telecommunications service provider and we grant Complainant's complaint.
- 2. In December 1998, the Commission released the *Section 258 Order* in which it adopted rules to implement Section 258 of the Communications Act of 1934 (Act), as amended by the Telecommunications Act of 1996 (1996 Act).³ Section 258 prohibits the practice of "slamming," the submission or execution of an unauthorized change in a subscriber's selection

of a provider of telephone exchange service or telephone toll service. In the *Section 258 Order*, the Commission adopted aggressive new rules designed to take the profit out of slamming, broadened the scope of the slamming rules to encompass all carriers, and modified its existing requirements for the authorization and verification of preferred carrier changes. The rules require, among other things, that a carrier receive individual subscriber consent before a carrier change may occur. Pursuant to Section 258, carriers are absolutely barred from changing a customer's preferred local or long distance carrier without first complying with one of the Commission's verification procedures. Specifically, a carrier must: (1) obtain the subscriber's written or electronically signed authorization in a format that meets the requirements of Section 64.1130; (2) obtain confirmation from the subscriber via a toll-free number provided exclusively for the purpose of confirming orders electronically; or (3) utilize an independent third party to verify the subscriber's order.

- 3. The Commission also has adopted liability rules. These rules require the carrier to absolve the subscriber where the subscriber has not paid his or her bill. In that context, if the subscriber has not already paid charges to the unauthorized carrier, the subscriber is absolved of liability for charges imposed by the unauthorized carrier for service provided during the first 30 days after the unauthorized change. Where the subscriber has paid charges to the unauthorized carrier, the Commission's rules require that the unauthorized carrier pay 150% of those charges to the authorized carrier, and the authorized carrier shall refund or credit to the subscriber 50% of all charges paid by the subscriber to the unauthorized carrier. Carriers should note that our actions in this order do not preclude the Commission from taking additional action, if warranted, pursuant to Section 503 of the Act. 10
- 4. We received Complainant's complaint on November 2, 2009, alleging that Complainant's telecommunications service provider had been changed from Verizon to MLD without Complainant's authorization. Pursuant to Sections 1.719 and 64.1150 of our rules, 11 we notified MLD of the complaint and MLD responded on December 1, 2009. 12 MLD states that

authorization was received and confirmed through third party verification (TPV). We have reviewed the TPV that MLD submitted with its response. MLD's verifier stated that the purpose of the conversation was "to verify and confirm your account information." However, the purpose of a TPV recording is to verify a subscriber's intent to change their preferred carrier. As we emphasized in the *Fourth Report and Order*, "any description of the carrier change transaction...shall not be misleading." We find that MLD actions were in violation of our carrier change rules, and we discuss MLD's liability below. 14

- 5. Pursuant to Section 64.1170(b) our rules, MLD must forward to Verizon an amount equal to 150% of all charges paid by the subscriber to MLD along with copies of any telephone bills issued from MLD. Within ten days of receipt of this amount, Verizon shall provide a refund or credit to Complainant in the amount of 50% of all charges paid by Complainant to MLD. Complainant has the option of asking Verizon to re-rate MLD charges based on Verizon rates and, on behalf of Complainant, seek from MLD, any re-rated amount exceeding 50% of all charges paid by Complainant to MLD. Verizon must also send a notice to the Commission, referencing this Order, stating that is has given a refund or credit to Complainant. If Verizon has not received the reimbursement required from MLD within 45 days of the release of this Order, Verizon must notify the Commission and Complainant accordingly. Verizon also must notify the Complainant of his or her right to pursue a claim against MLD for a refund of all charges paid to MLD.
- 6. Accordingly, IT IS ORDERED that, pursuant to Section 258 of the Communications Act of 1934, as amended, 47 U.S.C. § 258, and Sections 0.141, 0.361 and 1.719 of the Commission's rules, 47 C.F.R. §§ 0.141, 0.361, 1.719, the complaint filed against Multiline Long Distance IS GRANTED.
- 7. IT IS FURTHER ORDERED that, pursuant to Section 64.1170(b) of the Commission's rules, 47 C.F.R. § 64.1170(b), that Multiline Long Distance must forward to Verizon an amount equal to 150% of all charges paid by the subscriber along with copies of any telephone bills issued from the company to the Complainant within ten (10) days of the release of this order.

If Complainant is unsatisfied with the resolution of this complaint, Complainant may file a formal complaint with the Commission pursuant to Section 1.721 of the Commission's rules, 47 C.F.R. § 1.721. Such filing will be deemed to relate back to the filing date of Complainant's informal complaint so long as the formal complaint is filed within 45 days from the date this order is mailed or delivered electronically to Complainant. *See* 47 C.F.R. § 1.719.
