AGENDA ANNOUNCED FOR MAY 12 PUBLIC FORUM TO DISCUSS POTENTIAL ENHANCEMENTS TO THE SPECTRUM DASHBOARD

The Federal Communications Commission's public forum to discuss potential enhancements to the Spectrum Dashboard will be held at the FCC's Washington, D.C. headquarters on May 12, 2010, from 10:00 am – 1:00 pm.¹ The forum will include a presentation by Commission staff that highlights potential enhancements to the Spectrum Dashboard, summarizes current usage trends, and provides an overview of feedback received to date. In addition, panelists will provide presentations regarding their experience using the Spectrum Dashboard and make recommendations for potential enhancements.
