FORFEITURE ORDER

Adopted: May 10, 2010

Released: May 12, 2010

By the Regional Director, Western Region, Enforcement Bureau:

1. In this *Forfeiture Order* (“*Order*”), we issue a monetary forfeiture in the amount of three thousand dollars (\$3,000) to Multicultural Radio Broadcasting, Inc. (“MRBI”), registered owner of antenna structure # 1014422, in Pomona, California, for repeated violation Section 17.57 of the Commission’s Rules (“Rules”).¹ The noted violation involves MRBI’s failure to immediately notify the Commission of a change in ownership information for antenna structure # 1014422.

2. On May 4, 2009, the Enforcement Bureau’s Los Angeles District Office issued a *Notice of Apparent Liability for Forfeiture* (“*NAL*”) in the amount of \$3,000 to MRBI for failing to immediately notify the Commission of a change in ownership information for antenna structure # 1014422, in violation of Section 17.57 of the Rules.² Despite evidence that MRBI received the *NAL*, MRBI has not filed a response to the *NAL*. Based on the information before us, we affirm the forfeiture.

3. **ACCORDINGLY, IT IS ORDERED** that, pursuant to Section 503(b) of the Act,³ and Sections 0.111, 0.311 and 1.80(f)(4) of the Commission’s Rules,⁴ Multicultural Radio Broadcasting, Inc., **IS LIABLE FOR A MONETARY FORFEITURE** in the amount of \$3,000 for repeatedly violating Section 17.57 of the Rules.⁵

4. Payment of the forfeiture shall be made in the manner provided for in Section 1.80 of the Rules within 30 days of the release of this *Order*. If the forfeiture is not paid within the period specified, the case may be referred to the Department of Justice for collection pursuant to Section 504(a) of the Act.⁶ Payment of the forfeiture must be made by check or similar instrument, payable to the order of the

Federal Communications Commission. The payment must include the NAL/Account Number and FRN Number referenced above.
