**COMMENT SOUGHT ON REQUEST OF TELEPACIFIC COMMUNICATIONS  
FOR REVIEW OF A UNIVERSAL SERVICE CONTRIBUTION DECISION  
OF THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY  
AND A STAY OF THAT DECISION**

The Wireline Competition Bureau seeks comment on two requests filed by U.S. TelePacific Corp. d/b/a TelePacific Communications (TelePacific) on January 8, 2010. In the first request, TelePacific seeks review and reversal of a decision of the Universal Service Administrative Company that would reclassify certain revenues for purposes of universal service contribution assessments for calendar year 2007 and require TelePacific to refile its 2008 FCC Form 499-A by February 8, 2010.<sup>1</sup> In its second request, TelePacific seeks a stay of that decision.<sup>2</sup>

Interested parties may file **comments on or before January 29, 2010**, and **reply comments on or before February 3, 2010**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>3</sup>

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>6</sup>
