## MEDIA BUREAU ANNOUNCES COMMENT AND REPLY COMMENT DATES FOR THE NOTICE OF INQUIRY IN THE VIDEO DEVICE COMPETITION PROCEEDING

**Comment Date: July 13, 2010**  
**Reply Comment Date: August 12, 2010**

On April 21, 2010, the Commission adopted a *Notice of Inquiry* in the *Video Device Competition; Implementation of Section 304 of the Telecommunications Act of 1996: Competitive Availability of Navigation Devices; Compatibility Between Cable Systems and Consumer Electronics Equipment* proceeding.<sup>1</sup> In the *Notice of Inquiry*, the Commission requests comment on ways to foster a more competitive marketplace for navigation devices and in particular calls for comment on a standardized interface that enables smart video devices to bring video from a variety of sources, including, for example, cable or satellite, online video, and a consumer's home library, together for ease of selection, recording, and viewing.<sup>2</sup> The *Notice of Inquiry* set deadlines for filing comments and reply comments at 60 and 90 days after publication of the *Notice of Inquiry* in the Federal Register.

On May 14, 2010, a summary of the *Notice of Inquiry* was published in the Federal Register.<sup>3</sup> Accordingly, comments must be filed on or before July 13, 2010; and reply comments must be filed on or before August 12, 2010. Commenters should follow the filing instructions in the *Notice of Inquiry* beginning at paragraph 47.
