**COMMENT SOUGHT ON PETITION OF GRANDE COMMUNICATIONS NETWORKS
TO APPEAL A UNIVERSAL SERVICE CONTRIBUTION DECISION
OF THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY**

The Wireline Competition seeks comment on a petition filed by Grande Communications Networks (Grande).¹ Grande seeks review of a decision of the Universal Service Administrative Company that resulted in reclassification of certain of the company's revenues reported for purposes of universal service contribution assessments for calendar years 2004, 2005, and 2006.²

Interested parties may file **comments on or before February 18, 2010**, and **reply comments on or before March 5, 2010**. All pleadings are to reference **WC Docket No. 06-122**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.³

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

More than a one or two sentence description of the views and arguments presented generally is required.⁵ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁶
