COMMENT SOUGHT ON PETITION OF STANDING ROCK TELECOMMUNICATIONS FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER

The Wireline Competition Bureau seeks comment on a petition filed December 18, 2009, by Standing Rock Telecommunications, Inc. (SRTI), a tribal-government owned wireless carrier. SRTI seeks designation as an eligible telecommunications carrier for a service area coterminous with the existing rural study areas within the external boundaries of the Standing Rock Sioux Reservation in South Dakota and North Dakota.²

Interested parties may file **comments on or before February 18, 2010**, and **reply comments on or before March 5, 2010**. All pleadings are to reference **WC Docket No. 09-197**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.³
