The Wireline Competition Bureau seeks comment on a petition filed by Reliance Communications, Inc. and Reliance Communications International, Inc. (collectively, Reliance Communications). Reliance Communications seeks review and reversal of a decision of the Universal Service Administrative Company (USAC) denying Reliance Communications' request to accept its amended August 2009 FCC Form 499-Q.<sup>2</sup>

Interested parties may file **comments on or before June 21, 2010**, and **reply comments on or before July 6, 2010**. All pleadings are to reference **WC Docket No. 06-122**.
