**COMMENT SOUGHT ON THE PUERTO RICO TELEPHONE COMPANY, INC.  
PETITION FOR RECONSIDERATION OF THE COMMISSION'S UNIVERSAL SERVICE  
HIGH-COST INSULAR SUPPORT ORDER**

**Comment Date: 15 days after date of publication in the Federal Register**

The Wireline Competition Bureau seeks comment on a petition filed by Puerto Rico Telephone Company, Inc. (PRTC)<sup>1</sup> requesting that the Commission reconsider its decision declining to establish a new universal service high-cost support mechanism for non-rural insular carriers.<sup>2</sup> The Commission concluded that dramatic increases in telephone subscribership in Puerto Rico over the last several years made it unnecessary to adopt a new high-cost support mechanism for non-rural insular carriers as proposed by PRTC.

Pursuant to section 1.429(e) of the Commission's rules, interested parties may file **comments 15 days after the date of publication of this public notice in the Federal Register** and **reply comments 25 days after the date of publication of this public notice in the Federal Register**.<sup>3</sup> All pleadings are to reference **WC Docket No. 05-337**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>4</sup>

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>5</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>6</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>7</sup>
