ANNOUNCEMENT: The RPC Region 8 700 MHz Window #2 Application filing period will open September 1, 2010 and will run through September 30, 2010.

¹ Region 8 (New York – Metropolitan area) consists of Bronx, Kings, Nassau, New York, Orange, Putnam, Queens, Richmond, Rockland, Suffolk, Sullivan, Ulster, Dutchess, and Westchester Counties, New York; and Bergen, Essex, Hudson, Morris, Passaic, Sussex, Union, Warren, Middlesex, Somerset, Hunterdon, Mercer, and Monmouth Counties, New Jersey.

Immediately following the 700 MHz Public Safety RPC meeting, the 800 MHz Public Safety RPC meeting will convene at the same location.

It is essential that public safety agencies in all areas of government, including state, municipality, county, and Native American Tribal be represented in order to ensure that each agency's future spectrum needs are considered in the allocation process. Administrators who are not oriented in the communications field should delegate someone with this knowledge to attend, participate, and represent their agency's needs.
