On May 21, 2010, the Wireline Competition Bureau (Bureau) released a public notice<sup>1</sup> seeking comment on a petition filed by Puerto Rico Telephone Company, Inc. (PRTC)<sup>2</sup> requesting that the Commission reconsider its decision declining to establish a new universal service high-cost support mechanism for non-rural insular carriers.<sup>3</sup>

Pursuant to section 1.429(e) of the Commission's rules, the comment and reply comment deadline for the PRTC Petition is 15 days and 25 days, respectively, after publication of the *PRTC Petition Public Notice* in the Federal Register.<sup>4</sup> The *PRTC Petition Public Notice* was published in the Federal Register on May 28, 2010.<sup>5</sup> Accordingly, comments will be due on **June 14, 2010**, and reply comments will be due on **June 22, 2010**.
