ORDER

By the Deputy Chief, Telecommunications Access Policy Division, Wireline Competition Bureau:

1. Consistent with the Bureau's decision in the *Alton Order*,¹ we grant 24 appeals of decisions made by the Universal Service Administrative Company (USAC) that reduced or denied funding from the E-Rate program for various funding years on the grounds that the petitioners' invoice forms, either the FCC Form 472 or the FCC Form 474, were submitted late or not received by USAC.²

2. We first grant five petitioners waivers of our filing deadline for appeals³ because we find they submitted their appeals to the Commission within a reasonable period of time after receiving actual notice of USAC's adverse decision.⁴ Turning to the merits of the appeals, petitioners offer a number of explanations for submitting their invoices late or failing to submit them at all. These Petitioners either claim that the late or missed filings were the result of clerical, ministerial, or procedural errors,⁵ or were due to circumstances beyond their control.⁶

3. Consistent with the Commission's *Alton Order*,⁷ and based on our review of the record, we find that complete rejection of these requests for payment is not warranted given that the applicants missed a USAC procedural deadline and did not violate a Commission rule.⁸ Therefore, we remand the underlying applications to USAC for further action consistent with this order. To ensure that the underlying applications are resolved expeditiously, we direct USAC to complete its review of each application listed in the appendices and issue an award or a denial based on a complete review and analysis no later than 90 calendar days from release of this order.

4. ACCORDINGLY, IT IS ORDERED, pursuant to the authority contained in sections 1-4 and 254 of the Communications Act of 1934, as amended, 47 U.S.C. §§ 151-154 and 254, and pursuant to authority delegated in sections 0.91, 0.291, 1.3 and 54.722(a) of the Commission's rules, 47 C.F.R. §§ 0.91, 0.291, 1.3 and 54.722(a), that the Requests for Review and/or Requests for Waiver filed by the petitioners as listed in the appendices ARE GRANTED and the underlying applications ARE REMANDED to USAC for further consideration in accordance with the terms of this order.

5. IT IS FURTHER ORDERED, pursuant to the authority contained in sections 1-4 and 254 of the Communications Act of 1934, as amended, 47 U.S.C. §§ 151-154 and 254, and sections 0.91, 0.291, and 1.3 of the Commission's rules, 47 C.F.R. §§ 0.91, 0.291, and 1.3 of the Commission's rules, that section 54.720(a) of the Commission's rules, 47 C.F.R. § 54.720(a), ARE WAIVED for Canutillo Independent School District, Texas; Danex Systems, Inc. (FCC Form 471 application number 449656), Brooklyn, New York; Hamilton/Clermont Cooperative Association, Ohio; Pearl River Public School, New York; and Preble Shawnee Local School District, Ohio, to the extent necessary as provided herein.
