Special Temporary Authority  
Grant of Authority Effective Date: 08/18/2011

On August 18, 2011, the Satellite Division granted, with conditions, special temporary authority to Intelsat License LLC, for a period of 10 days, commencing August 12, 2011, to continue telemetry, tracking, and telecommand operations with the Intelsat 702 space station necessary to maintain Intelsat 702 at the 54.85° E.L. orbital location using the following center frequencies: 6173.7 MHz and 6176.3 MHz (left-hand circular polarization/Earth-to-space); 3947.5 MHz, 3948.0 MHz, 3952.5 MHz, and 3952.0 MHz (right-hand circular polarization/space-to-Earth). Additionally, Intelsat is granted special temporary authority during the same 10-day period to continue to provide fixed-satellite service at the 54.85° E.L. orbital location using the 3700-4200 MHz (space-to-Earth), 5925-6425 MHz (Earth-to-space), 10.95-11.2 GHz (space-to-Earth), 11.45-11.70 GHz, (space-to-Earth), 12.50-12.75 GHz (space-to-Earth), and 14.0-14.5 GHz (Earth-to-space) frequency bands.

Special Temporary Authority  
Grant of Authority Effective Date: 08/18/2011

On August 18, 2011, the Satellite Division granted, with conditions, special temporary authority to Intelsat License LLC for a period of 30 days to operate telemetry, tracking, and telecommand operations with the Intelsat 706 space station necessary to effect the drift of the space station from the 72.1° E.L. orbital location to the 72.0° E.L. orbital location, and to maintain Intelsat 706 at 72.0° E.L., using the following frequencies: 6173.7 MHz and 6176.3 MHz (left-hand circular polarization/Earth-to-space); 3947.5 MHz, 3948.0 MHz, 3952.5 MHz, and 3952.0 MHz (right-hand circular polarization/space-to-Earth). Additionally, Intelsat is granted authority to provide Fixed-Satellite Service during the drift to and while located at the 72.0° E.L. orbital location on a temporary basis using the 3700-4200 MHz (space-to-Earth), 5925-6425 MHz (Earth-to-space), 10.95-11.2 GHz (space-to-Earth), 11.45-11.70 GHz, (space-to-Earth), 12.50-12.75 GHz (space-to-Earth), and 14.0-14.5 GHz (Earth-to-space) frequency bands.
