REGION 35 (OREGON) PUBLIC SAFETY REGIONAL PLANNING COMMITTEES
TO HOLD 700 MHZ AND 800 MHZ NPSPAC MEETINGS**

The Region 35 (Oregon)¹ Public Safety Regional Planning Committees (RPCs) will hold two planning meetings on Thursday, September 29, from 10 a.m. until 12 noon at the Washington County Consolidated Communications Agency, Lower Training Room, 17911 N.W. Evergreen Parkway, Beaverton, Oregon.

- 4.9 GHz spectrum coordination

Immediately following the 700 MHz Public Safety RPC meeting, the 800 MHz Public Safety RPC meeting will convene at the same location.

- Approve Newberg site move to Mountain Top site
- Accessing frequency allocations through CAPRAD²
- Re-writing the 800 MHz Plan
- Adjourn

Both Region 35 700 and 800 MHz Public Safety RPC meetings are open to the public. All eligible public safety providers in Region 35 may utilize these frequencies. It is essential that eligible public safety agencies in all areas of government, including state, municipality, county, and Native American Tribal be represented in order to ensure that each agency's future spectrum needs are
