## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON AIRVOICE WIRELESS, LLC PETITION FOR FORBEARANCE FROM ELIGIBLE TELECOMMUNICATIONS CARRIER FACILITIES REQUIREMENT

The Wireline Competition Bureau seeks comment on a petition filed on September 13, 2011 by Airvoice Wireless, LLC (AVW), a commercial mobile radio services reseller, for forbearance from the requirement in section 214(e)(1)(A) of the Communications Act of 1934, as amended, that eligible telecommunications carriers (ETCs) provide service, at least in part, over their own facilities.<sup>1</sup> AVW seeks forbearance to enable it to be designated an ETC for the limited purposes of receiving universal service Lifeline support.<sup>2</sup>

Interested parties may file **comments on or before October 20, 2011**, and **reply comments on or before November 4, 2011**. All pleadings are to reference **WC Docket No. 09-197**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>3</sup>

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- Paper Filers: Parties who choose to file by paper must file an original and one copy of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>6</sup>
