WIRELINE COMPETITION BUREAU SEEKS COMMENT ON ANNETTE ISLAND SERVICE UNIT REQUEST FOR WAIVER OF THE RURAL HEALTH CARE FCC FORM 466 FILING DEADLINE

The Wireline Competition Bureau seeks comment on a request filed by Annette Island Service Unit (Annette Island) seeking a waiver of the rural health care FCC Form 466 filing deadline.<sup>1</sup> Specifically, Annette Island argues that as the island's lone health care facility, the error will significantly impact the island community.<sup>2</sup>

Interested parties may file **comments on or before November 21, 2011,** and **reply comments on or before December 5, 2011.** All pleadings are to reference **WC Docket No. 02-60.** Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>3</sup>

More than a one or two sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>6</sup>
