WIRELINE COMPETITION BUREAU SEEKS COMMENT ON HORIZON HEALTH CARE, INC. REQUEST FOR REVIEW OF DECISION BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

The Wireline Competition Bureau seeks comment on a request filed by Horizon Health Care, Inc. (Horizon) seeking review of a decision of the Universal Service Administrative Company (USAC) in which USAC determined that Horizon's administrative office is not a health care provider under section 54.601(1) of the Commission's rules and is not eligible to receive benefits under the Rural Health Care Pilot Program.¹

Interested parties may file **comments on or before November 21, 2011,** and **reply comments on or before December 5, 2011.** All pleadings are to reference **WC Docket No. 02-60.** Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.²

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.³ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁴ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁵
