## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON NTCH'S COMPLIANCE PLAN FOR THE PROVISION OF LIFELINE SERVICE

WC Docket No. 09-197

Comment Date: November 25, 2011

The Wireline Competition Bureau seeks comment on the proposed compliance plan filed by NTCH, Inc. and its affiliated entities (collectively, NTCH) for the provision of Lifeline service.<sup>1</sup> By filing this compliance plan, NTCH seeks to satisfy the conditions imposed by the Commission in a recent Forbearance Order granting NTCH forbearance from the requirement that its service area conform to the underlying service area of the rural telephone company for participation in the Lifeline program.<sup>2</sup>

Interested parties may file **comments on or before November 25, 2011, and reply comments on or before December 9, 2011**. All pleadings are to reference **WC Docket No. 09-197**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>3</sup>

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- Paper Filers: Parties who choose to file by paper must file an original and one copy of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.<sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>6</sup>
