## **ORDER**

Adopted: October 27, 2011 Released: October 31, 2011

By the Deputy Chief, Consumer Policy Division, Consumer & Governmental Affairs Bureau:

- 1. In this Order, we consider the complaint<sup>1</sup> alleging that LDC Telecommunications, Inc. c/o Intercontrollers, Inc., (LDC) changed Complainant's telecommunications service provider without obtaining authorization and verification from Complainant in violation of the Commission's rules.<sup>2</sup> We conclude that LDC's actions violated the Commission's carrier change rules and we grant Complainant's complaint.
- 2. In December 1998, the Commission released the *Section 258 Order* in which it adopted rules to implement Section 258 of the Communications Act of 1934 (Act), as amended by the Telecommunications Act of 1996 (1996 Act).<sup>3</sup> Section 258 prohibits the practice of

"slamming," the submission or execution of an unauthorized change in a subscriber's selection of a provider of telephone exchange service or telephone toll service. In the *Section 258 Order*, the Commission adopted aggressive new rules designed to take the profit out of slamming, broadened the scope of the slamming rules to encompass all carriers, and modified its existing requirements for the authorization and verification of preferred carrier changes. The rules require, among other things, that a carrier receive individual subscriber consent before a carrier change may occur. Pursuant to Section 258, carriers are absolutely barred from changing a customer's preferred local or long distance carrier without first complying with one of the Commission's verification procedures. Specifically, a carrier must: (1) obtain the subscriber's written or electronically signed authorization in a format that meets the requirements of Section 64.1130; (2) obtain confirmation from the subscriber via a toll-free number provided exclusively for the purpose of confirming orders electronically; or (3) utilize an independent third party to verify the subscriber's order.

- 3. The Commission also has adopted liability rules. These rules require the carrier to absolve the subscriber where the subscriber has not paid his or her bill. In that context, if the subscriber has not already paid charges to the unauthorized carrier, the subscriber is absolved of liability for charges imposed by the unauthorized carrier for service provided during the first 30 days after the unauthorized change. Where the subscriber has paid charges to the unauthorized carrier, the Commission's rules require that the unauthorized carrier pay 150% of those charges to the authorized carrier, and the authorized carrier shall refund or credit to the subscriber 50% of all charges paid by the subscriber to the unauthorized carrier. Carriers should note that our actions in this order do not preclude the Commission from taking additional action, if warranted, pursuant to Section 503 of the Act. 10
- 4. We received Complainant's complaint on October 20, 2010, alleging that Complainant's telecommunications service provider had been changed to LDC without Complainant's authorization. Pursuant to Sections 1.719 and 64.1150 of our rules, 11 we notified

LDC of the complaint.<sup>12</sup> LDC has failed to respond to the complaint within 30 days. The failure of LDC to respond or provide proof of the verification within the required 30 days is presumed to be clear and convincing evidence of a violation.<sup>13</sup> Therefore, we find that LDC's actions resulted in a violation of our carrier change rules and we discuss LDC's liability below.<sup>14</sup> We also will forward a copy of the record of this proceeding to our Enforcement Bureau to determine what additional action may be necessary.

- 5. LDC must remove all charges incurred for service provided to Complainant for the first thirty days after the alleged unauthorized change in accordance with the Commission's liability rules. We have determined that Complainant is entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred and that LDC may not pursue any collection against Complainant for those charges. Any charges imposed by LDC on the subscriber for service provided after this 30-day period shall be paid by the subscriber to their authorized carrier at the rates the subscriber was paying at the time of the unauthorized change. 17
- 6. Accordingly, IT IS ORDERED that, pursuant to Section 258 of the Communications Act of 1934, as amended, 47 U.S.C. § 258, and Sections 0.141, 0.361 and 1.719 of the Commission's rules, 47 C.F.R. §§ 0.141, 0.361, 1.719, the complaint filed against LDC Telecommunications, Inc. c/o Intercontrollers, Inc., IS GRANTED.
- 7. IT IS FURTHER ORDERED that, pursuant to Section 64.1170(d) of the Commission's rules, 47 C.F.R. § 64.1170(d), Complainant is entitled to absolution for the charges incurred during the first thirty days after the unauthorized change occurred and LDC may not pursue any collection against Complainant for those charges.

Notice of Informal Complaint IC 10-S2833307 was mailed on October 28, 2010. On November 10, 2010, the Commission received the certified mail return receipt confirming delivery was made.
