By the Chief, Consumer & Governmental Affairs Bureau:

I. INTRODUCTION

1. By this Order, the Consumer & Governmental Affairs Bureau (CGB) terminates, as dormant, the proceedings listed on the Attachment hereto, which were also listed in the Attachment to the Public Notice on Termination of Certain Proceedings as Dormant released on June 3, 2011.

2. Upon publication of this Order in the Federal Register, these proceedings will be terminated in the Electronic Comment Filing System (ECFS). The record in the terminated proceedings will remain part of the Commission's official records, and the various pleadings, orders, and other documents in these dockets will continue to be accessible to the public, post-termination.

II. BACKGROUND

3. On February 4, 2011, the Commission released a Report and Order that, inter alia, amended Section 0.141 of the Commission's organizational rules to delegate authority to the Chief, CGB to conduct periodic review of all open dockets with the objective of terminating those that were inactive.

4. Following the release of the Procedure Order, CGB, in consultation with the relevant other bureaus and offices, conducted a review of all open dockets and identified those dockets that could potentially be terminated. As a result of that process, CGB issued the Termination Public Notice, listing

the open dockets under consideration for termination, and providing interested parties the opportunity to file comments on these proposed terminations. Based upon our review of the six comments received in response to the *Termination Public Notice*,⁴ for the reasons given below, we hereby terminate the proceedings listed in the Attachment to this Order.⁵

III. DISCUSSION

5. Commenters were generally supportive of the Commission's efforts to terminate as dormant outdated pending proceedings as a continuation of the Commission's focus on efficiency, transparency and expeditious resolution of rulemaking proceedings.⁶ We received six comments requesting that particular proceedings noted in the *Termination Public Notice* remain open. Based upon our review of these comments, for the reasons noted below, we reject each of these requests and terminate the proceedings at issue.

6. **REC Networks.** REC Networks asks that we maintain as active three proceedings—RM-9246, RM-9682 and RM-10995—that relate to LPFM and FM translator services.⁷ However, on July 12, 2011, the Commission released a Third Notice of Proposed Rulemaking in two dockets that relate specifically to those services, and, given the common subject matter, the materials in each of the proceedings that REC Networks seeks to keep open may be refiled in these two dockets.⁸ For this reason, we deny REC Networks' request to keep these proceedings open.⁹

7. **Jonathan E. Hardis.** Mr. Hardis requests that Docket No. RM-9395¹⁰ remain open. Even though he acknowledges that there has been no activity in the proceeding in over 11 years and none is expected, Mr. Hardis maintains that the Docket may contain material that is related to ongoing MM Docket No. 99-325.¹¹ With no activity in over a decade, we find that Docket No. RM-9395 is dormant and reject the request of Mr. Hardis to keep it open. However, to address his concerns regarding the continued availability of the materials in the RM-9395 record, as noted in paragraph 2 above, we will maintain submissions from all terminated proceedings in ECFS for research purposes.

8. **Nickolaus E. Leggett.** Mr. Leggett requests that we keep Docket No. RM-10412¹² open to allow various parties to submit additional comments on regulatory steps that would enhance certain aspects of the Amateur Radio Service.¹³ However, on April 15, 2004, the Commission released a Notice of Proposed Rulemaking and Order which specifically denied RM-10412.¹⁴ Since, by this action, RM-10412 should have already have been closed, we reject Mr. Leggett's request to keep it open.¹⁵

9. **ARRL, the National Association for Amateur Radio.** ARRL, formerly known as the American Radio Relay League, Incorporated, objects to the dismissal of its Petition for Rulemaking, *Amendment of Part 2 and Part 97 of the Commission's Rules Regarding the 2300-2305 MHz Band*, RM-10165, in which ARRL requested that the Amateur Radio Service allocation status in the 2300-2305 MHz band be changed from secondary to primary.¹⁶ ARRL originally filed its Petition on May 7, 2001, and the

Commission placed it on Public Notice on July 2, 2001.¹⁷ On October 10, 2002, the Commission's Office of Engineering and Technology (OET) issued an *Order* dismissing ARRL's Petition.¹⁸

10. ARRL claims that the *OET Order* did not resolve the issue of the allocation status of the Amateur Radio Service in the 2300-2305 MHz band, or ARRL's request for a primary allocation in that segment.¹⁹ ARRL maintains that the status of the Amateur Radio Service allocation at 2300-2305 MHz remains relevant because of actions taken by the Commission with respect to an adjacent band at 2305-2320 MHz; because ARRL has filed a Petition for Reconsideration regarding the actions taken in the 2305-2320 MHz band; and due to other unrelated proposals for use of the 2300-2305 MHz band.²⁰

11. Regarding the 2305-2320 MHz band, in May 2010, the Commission issued an Order that amended certain rules governing the Wireless Communications Service ("WCS") to enable WCS licensees to provide mobile broadband services.²¹ In doing so, the Commission acknowledged that out-of-band emissions that could result from expanded use of WCS mobile devices in the 2305-2320 MHz band have the potential to increase interference to amateur radio operations in the 2300-2305 MHz band.²² During the course of the WCS proceeding, however, ARRL did not file any comments raising the issue of whether the Amateur Radio Service allocation status in the 2300-2305 MHz band should be modified. Although ARRL filed a Petition for Reconsideration of the *WCS Order*,²³ it did not request a change in the status of the Amateur Radio Service allocation at 2300-2305 MHz in that filing. In its Reply Comments to the Opposition to its WCS Petition, ARRL specifically stated that it was not asking the Commission to revisit any aspect of its past decisions regarding that status.²⁴

12. We believe that the RM-10165 proceeding concerning ARRL's request to change the status of the Amateur Radio Service to primary in the 2300-2305 MHz band should be terminated, since its request was dismissed and ARRL did not file a petition for reconsideration of that dismissal. Although the Commission's dismissal of RM-10165 left open the possibility that the allocation status for the Amateur Radio Service in this band could be considered again when the reserve status of that spectrum is evaluated, there has been no activity in that proceeding since October 2002. Furthermore, although ARRL raises a

concern that a 2009 *Notice of Proposed Rulemaking* proposed a secondary allocation in the 2300-2305 MHz band for Medical Body Area Networks, in that proceeding, the Commission did not seek comment on or propose to modify the Amateur Radio Service allocation in the 2300-2305 MHz band.²⁵ In addition, we do not believe that the issues ARRL has raised on reconsideration in the WCS proceeding warrant holding open the RM-10165 proceeding. If ARRL still desires a change in the Amateur Radio Service allocation status in the 2300-2305 MHz band, it can file a new petition for rulemaking. Accordingly, RM-10165 is terminated.

13. **Donald J. Schellhardt and Nickolaus E. Leggett.** Mr. Schellhardt and Mr. Leggett request that Docket No. RM-5528²⁶ remain open.²⁷ However, RM-5528 was dismissed by Memorandum Opinion and Order released by the Commission's Common Carrier Bureau on April 22, 1987.²⁸ Mr. Schellhardt and Mr. Leggett filed a subsequent Petition for Reconsideration which was denied in a Memorandum Opinion and Order released on May 8, 1987.²⁹ Since RM-5528 was closed by this previous action, we reject the request that the proceeding remain open.

14. **James Edwin Whedbee.** Finally, Mr. Whedbee agrees that a number of the Commission's docketed proceedings are dormant, obsolete, or subsumed in other intervening proceedings.³⁰ However, he suggests that termination of proceedings for dormancy is not just cause for the termination of a proceeding on the merits. Accordingly, he maintains that the Administrative Procedure Act may be violated by the dismissal of dormant dockets that are not otherwise obsolete or subsumed, and recommends that we leave open those docketed proceedings which are "merely dormant for want of sufficiency of notice of their impending termination."³¹

15. In the Notice of Proposed Rulemaking released in this matter on February 22, 2010, the Commission proposed, *inter alia*, that Section 0.141 be amended to delegate authority to the Chief, CGB to terminate dormant proceedings, and invited public comment on the proposed termination process.³² After due consideration of the comments filed in that proceeding, the change to the rule, which was supported in the comments received, was duly adopted in the *Procedure Order*.³³ Mr. Whedbee had an opportunity but failed to file his objection to the proposed amendment to Section 0.141. Because the merits of that final action are outside of the scope of the instant proceeding, we reject his argument as an

untimely petition for reconsideration. We note that the *Termination Public Notice* provided clear notice of CGB's intention to terminate for dormancy all of the proceedings that are the subject of this Order, and gave any interested party the opportunity to substantively comment on each such possible termination. As noted above, each such argument specific to a particular proceeding or proceedings that has been submitted has been fully considered herein.
