**ORDER**

**Adopted: November 10, 2011**

By the Chief, Wireline Competition Bureau:

1. In this Order, the Wireline Competition Bureau (Bureau) grants a petition to extend the temporary assignment<sup>1</sup> of three toll free numbers to the Substance Abuse and Mental Health Services Administration (SAMHSA). SAMHSA and the Kristin Brooks Hope Center (KBHC) jointly filed the petition for extension.<sup>2</sup> The Bureau's current assignment of the three toll free numbers expires on

November 14, 2011.<sup>3</sup> The Bureau grants the parties' request and extends the current temporary assignment until December 30, 2011.

2. The Commission's Order assigning these three toll free numbers from KBHC to SAMHSA<sup>4</sup> was remanded to the Commission by the U.S. Court of Appeals for the D. C. Circuit on December 3, 2010.<sup>5</sup> The Bureau sought comment on issues raised in the *D.C. Court Remand*, and both KBHC and SAMHSA responded.<sup>6</sup> In their request for an extension, SAMHSA and KBHC state that "[g]iven the numerous legal and factual issues raised in the remand proceeding" an extension will "better enable the Commission to review the detailed information provided by the parties...."<sup>7</sup> We agree with the parties and find that good cause exists to extend the current assignment until December 30, 2011.

3. Accordingly, IT IS ORDERED that, pursuant to sections 1, 4(i) and 251(e) of the Communications Act of 1934, as amended, 47 U.S.C. §§ 151, 154(i), and 251(e), sections 1.3 and 52.111 of the Commission's rules, 47 C.F.R. §§ 1.3 and 52.111, and pursuant to authority delegated under sections 0.91 and 0.291 of the Commission's rules, 47 C.F.R. §§ 0.91 and 0.291,<sup>8</sup> the current assignment of toll free numbers 1-800-784-2433 (1-800-SUICIDE), 1-877-784-2432 (1-877-SUICIDA), and 1-888-784-2433 (1-888-SUICIDE) to the Substance Abuse and Mental Health Services Administration IS EXTENDED to December 30, 2011.
