WIRELINE COMPETITION BUREAU SEEKS COMMENT ON COMPLIANCE PLAN OF PLATINUMTEL COMMUNICATIONS, LLC FOR CONDITIONS ASSOCIATED WITH FORBEARANCE

The Wireline Competition Bureau seeks comment on the proposed compliance plan filed by PlatinumTel Communications, LLC. (PlatinumTel).¹ By filing this compliance plan, PlatinumTel seeks to satisfy the conditions imposed by the Commission in granting PlatinumTel's petition to forbear from the requirement that carriers designated as eligible telecommunications carriers (ETCs) for purposes of federal universal service support provide services, at least in part, over their own facilities in order to participate in the Lifeline program.²

Interested parties may file **comments on or before December 15, 2011, and reply comments on or before December 30, 2011**. All pleadings are to reference **WC Docket No. 09-197**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.³

- **Electronic Filers:** Comments may be filed electronically using the Internet by accessing the ECFS: <http://fjallfoss.fcc.gov/ecfs2/>.
- **Paper Filers:** Parties who choose to file by paper must file an original and one copy of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules.⁴ Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required.⁵ Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.⁶
