## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON INDIAN HEALTH SERVICE – WHITE SWAN HEALTH STATION REQUEST FOR REVIEW OF A DECISION BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

On December 1, 2011, the Indian Health Service – White Swan Health Station (White Swan) filed a request seeking review of a decision of the Universal Service Administrative Company (USAC) in which USAC determined that White Swan was not located in a rural area under section 54.5 of the Commission's rules and is not eligible to receive benefits under the Rural Health Care program.<sup>1</sup>

Interested parties may file **comments on or before January 18, 2012**, and **reply comments on or before February 2, 2012**. All pleadings are to reference **WC Docket No. 02-60**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>2</sup>

More than a one or two sentence description of the views and arguments presented generally is required.<sup>4</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>5</sup>
