On November 15, 2011, Northeast Montana Health Services (Northeast Montana) filed a request seeking review of a decision of the Universal Service Administrative Company (USAC) in which USAC reduced Northeast Montana's funding request for Funding Year 2010 under the Rural Health Care program.¹ In its request, Northeast Montana asserts that USAC erroneously determined the service contract termination date.²

Interested parties may file comments on or before January 18, 2012, and reply comments on or before February 2, 2012. All pleadings are to reference WC Docket No. 02-60. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.³
