In this Notice, the Wireline Competition Bureau seeks comment on a petition filed by the Montana Public Service Commission (Montana Commission) for authority to implement number conservation measures.¹ Specifically, the Montana Commission seeks delegated authority to implement mandatory thousands-block number pooling in the 406 Numbering Plan Area to ensure that the public is protected from the expense and confusion related to premature area code splits or overlays.²
