WIRELINE COMPETITION BUREAU SEEKS COMMENT ON THE VIRGIN ISLANDS TELEPHONE CORP. D/B/A INNOVATIVE TELEPHONE PETITION FOR WAIVER OF THE NATIONAL EXCHANGE CARRIER ASSOCIATION ADJUSTMENT PERIOD FOR CALCULATING HIGH COST LOOP SUPPORT

The Wireline Competition Bureau seeks comment on a petition filed by Virgin Islands Telephone Corp. d/b/a Innovative Telephone (Innovative) to waive the National Exchange Carrier Association's (NECA) rolling 24-month adjustment period and require that NECA recalculate Innovative's 2011 High Cost Loop Support (HCLS) based on corrected loop count data. Innovative claims that its 2009 loop count data submitted to NECA was inaccurate because Innovative had been erroneously including loops that were related to non-switched wideband services. <sup>2</sup>

Interested parties may file **comments on or before January 23, 2012**, and **reply comments on or before February 7, 2012**. All pleadings are to reference **WC Docket No. 08-71**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>3</sup>
