WIRELINE COMPETITION BUREAU SEEKS TO REFRESH RECORD ON PETITIONS FOR WAIVER OF COMMISSION'S RULES REGARDING ACCESS TO NUMBERING RESOURCES

By this Public Notice, we seek to refresh the record on numerous petitions for limited waiver of section 52.15(g)(2)(i) of the Commission's rules to allow the requesting Voice over Internet Protocol (VoIP) providers direct access to numbering resources from the North American Numbering Plan Administrator and the Pooling Administrator.¹

As part of this record, earlier this year, Vonage Holdings Corporation (Vonage) renewed its request for a waiver and filed supplemental materials in support of its petition.² Vonage asserts that direct

access to numbering resources will promote the deployment of new and innovative services, lead to lower consumer prices for VoIP service, improve the quality of Vonage's services, and promote the Commission's goal of moving toward an all IP network.

Given the time that has elapsed since these various petitions, including Vonage's, were filed, we seek to ensure that the record reflects current viewpoints on any issues raised by providing direct access to numbering resources for VoIP providers.

Interested parties may file comments on or before January 11, 2012. All pleadings should reference CC Docket No. 99-200.
