NEW CINGULAR WIRELESS PCS, LLC AND COMMNET OF FLORIDA, LLC SEEK FCC CONSENT TO THE ASSIGNMENT OF ONE CELLULAR LICENSE

I. INTRODUCTION

New Cingular Wireless PCS, LLC (“New Cingular”) and Commnet of Florida, LLC (“Commnet”) (collectively, “the Applicants”) have filed an application pursuant to Section 310(d) of the Communications Act of 1934, as amended,¹ seeking to assign a cellular license from Commnet to New Cingular in CMA370 FL-11 Monroe. New Cingular is an indirect, wholly-owned subsidiary of AT&T Inc. (“AT&T”). The Applicants propose to complete the transaction through a two-step process: first, they propose to assign the license for cellular call sign WPSJ791 from Commnet to Reef Acquisition Company LLC (“Reef”), a direct wholly-owned subsidiary of Commnet, and second, immediately thereafter, they propose to transfer control of Reef to New Cingular.

The Applicants state that the additional spectrum will enable AT&T to augment its network capacity in order to enhance the scope and depth of services offered in Monroe County, Florida. Specifically, the additional spectrum will, according to the Applicants, facilitate the provision of additional products and services to the public in this market as well as the continued deployment of GSM/EDGE and HSDPA/UMTS/LTE technologies. Preliminary review of the application indicates that in this market, post-transaction AT&T would hold 68 megahertz of spectrum below 1 GHz.²

II. SECTION 310(d) APPLICATION

The application for consent to the full assignment of the cellular license from Commnet to New Cingular, through Reef, has been assigned the following file number:

III. *EX PARTE* STATUS OF THIS PROCEEDING

Pursuant to Section 1.1200(a) of the Commission's rules,³ the Commission may adopt modified or more stringent *ex parte* procedures in particular proceedings if the public interest so requires.⁴ We announce that this proceeding will be governed by permit-but-disclose *ex parte* procedures that are applicable to non-restricted proceedings under Section 1.1206 of the Commission's rules.⁵

Parties making oral *ex parte* presentations are directed to the Commission's statement reemphasizing the public's responsibility in permit-but-disclose proceedings and are reminded that memoranda summarizing the presentation must contain the presentation's substance and not merely list the subjects discussed.⁶ More than a one- or two-sentence description of the views and arguments presented is generally required.⁷ Other rules pertaining to oral and written presentations are set forth in Section 1.1206(b) as well.⁸

IV. GENERAL INFORMATION

The assignment application referenced herein has been found, upon initial review, to be acceptable for filing. The Commission reserves the right to return any application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules or policies.

Interested parties must file petitions to deny no later than March 2, 2011. Persons and entities that file petitions to deny become parties to the proceeding. They may participate fully in the proceeding, including seeking access to any confidential information that may be filed under a protective order, seeking reconsideration of decisions, and filing appeals of a final decision to the courts. Oppositions to such pleadings must be filed no later than March 14, 2011. Replies to such pleadings must be filed no later than March 5, 2011. All filings concerning matters referenced in this Public Notice should refer to ULS File No. 0004541107.

Under the Commission's current procedures for the submission of filings and other documents,⁹ submissions in this matter may be filed electronically (*i.e.*, though the Commission's Universal Licensing System ("ULS")) or by hand delivery to the Commission.
