WIRELINE COMPETITION BUREAU SEEKS COMMENT ON REQUESTS FOR WAIVER OF THE RURAL HEALTH CARE PILOT PROGRAM FIVE-YEAR INVOICING DEADLINE

On December 9, 2010, the Wireline Competition Bureau (Bureau) issued a public notice seeking comment on a filing by the Michigan Public Health Institute (MPHI)¹ requesting a waiver of the Rural Health Care Pilot Program's (Pilot Program's) five-year invoicing deadline.²

Numerous Pilot Program participants have filed similar requests seeking waiver of the five-year invoicing deadline: general waiver (Kentucky Behavioral Telehealth Network and New England Telehealth Consortium);³ one year (California Telehealth Network, and Pacific Basin Telehealth Demonstration Project);⁴ fifteen months (Virginia Telehealth Network and West Virginia Telehealth

Alliance); ⁵ three years (Arkansas Telehealth Network, and Health Information Exchange of Montana, Inc.); ⁶ and five years from each funding commitment letter (Indiana Telehealth Network, New England Telehealth Consortium, Virginia Telehealth Network, and Western Regional New York Area Health Education Network).⁷

Interested parties may file **comments on or before March 24, 2011,** and **reply comments on or before April 8, 2011.** All pleadings are to reference **WC Docket No. 02-60**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.⁸

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <u>http://www.fcc.gov/cgb/ecfs/</u>. Filers should follow the instructions provided on the website for submitting comments.
- For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions, filers should send an e-mail to ecfs@fcc.gov, and include the following words in the body of the message, "get form." A sample form and directions will be sent in response.
- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by firstclass or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). All filings must be addressed to the Commission's Secretary, Office of the Secretary, Federal Communications Commission.
