## NOTICE OF PROPOSED RULEMAKING

Adopted: February 22, 2011 Released: March 2, 2011

Comment Date: [30 days after date of publication in the Federal Register] Reply Comment Date: [45 days after date of publication in the Federal Register]

By the Chief, Video Division, Media Bureau:

- 1. The Commission has before it a petition for rulemaking filed by KSQA, LLC ("KSQA"), permittee of station KSQA(TV), channel 12, Topeka, Kansas, <sup>1</sup> requesting the substitution of channel 22 for channel 12 at Topeka.
- 2. KSQA states that the proposed channel 22 facility at Topeka "avoids the interference problems which exist on [c]hannel 12." KSQA explains that "there are post-transition full-power digital television stations operating on both channels first-adjacent to KSQA ([c]hannels 11 and 13) in Topeka," and as the two stations, stations KTWU(TV), Topeka, Kansas and WIBW-TV, Topeka, Kansas, respectively, do not operate from the same transmitter site, it is "extremely difficult for KQSA to find a suitable site from which to operate a [c]hannel 12 facility with effective radiated power, antenna height, and antenna pattern similar to those of KTWU[(TV)] and WIBW-[TV]." KSQA concludes that the proposed channel 22 facility will be in compliance the Commission's technical rules.
- 3. We believe that KSQA's proposal warrants consideration. Channel 22 can be substituted for channel 12 at Topeka, Kansas as proposed, in compliance with the principal community coverage

requirements of Section 73.625(a) of the Commission's rules,<sup>5</sup> at coordinates 39-03-50 N. and 95-45-49 W. In addition, we find that this channel change meets the technical requirements set forth in Sections 73.616 and 73.623 of the Commission's rules.<sup>6</sup> We propose to substitute channel 22 for channel 12 for station KSQA(TV) at Topeka with the following specifications:

4. Accordingly, we seek comments on the proposed amendment of the Post-Transition Table of DTV Allotments, Section 73.622(i) of the Commission's rules, for the community listed below, to read as follows:

- 5. The Commission's authority to institute rule making proceedings, showings required, cutoff procedures, and filing requirements are contained in the attached Appendix and are incorporated by
  reference herein. Pursuant to Section 73.623(h) of the rules, mutually-exclusive applicants will be provided
  a 90-day period of time, from the date of a public notice identifying mutually-exclusive proposals, to resolve
  their mutual-exclusivity via engineering amendment or settlement.<sup>8</sup> If we receive an application on or
  before the date for filing initial comments in this proceeding, which proposes a facility which is mutuallyexclusive with the proposal set forth herein, we will issue a public notice and the parties will have 90 days
  within which to resolve their mutual-exclusivity. If the parties resolve their mutual-exclusivity, we will
  complete the rulemaking process by issuing the appropriate order. If the parties are unable to resolve their
  mutual-exclusivity, we will terminate this proceeding and dismiss the application.
- 6. Pursuant to Sections 1.415 and 1.419 of the Commission's rules, interested parties may file comments on or before [30 days after publication in the Federal Register] and reply comments on or before [45 days after publication in the Federal Register], and are advised to read the Appendix for the proper procedures. Comments should be filed with the Federal Communications Commission, Office of the Secretary, 445 12th Street, S.W., Washington, D.C. 20554. Additionally, a copy of such comments should be served on the petitioner, or its counsel or consultant, as follows:

- Parties must file an original and four copies of each filing. Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). The Commission's contractor will receive hand-delivered or messenger-delivered paper filings for the Commission's Secretary at the FCC Headquarters Building located at 445 12<sup>th</sup> Street, S.W., Room TW-A325, Washington, D.C. 20554. The filing hours at this location are Monday through Friday, 8:00 a.m. to 7:00 p.m. All hand deliveries must be held together with rubber bands or fasteners. Any envelopes must be disposed of before entering the building. Commercial overnight mail (other than U.S. Postal Service Express Mail or Priority Mail) must be sent to 9300 East Hampton Drive, Capitol Heights, Maryland 20743. The Commission has determined that the relevant provisions of the Regulatory Flexibility Act of 1980 do not apply to a rule making proceeding to amend the DTV Table of Allotments, Section 73.622(i). This document does not contain proposed information collection requirements subject to the Paperwork Reduction Act of 1995, Public Law 104-13. In addition, therefore, it does not contain any proposed information collection burden "for small business concerns with fewer than 25 employees," pursuant to the Small Business Paperwork Relief Act of 2002, Public Law 107-198, § 3506(c)(4).

For purposes of this restricted notice and comment rule making proceeding, members of the public are advised that no *ex parte* presentations are permitted from the time the Commission adopts a Notice of Proposed Rule Making until the proceeding has been decided and such decision in the applicable docket is no longer subject to reconsideration by the Commission or review by any court. An *ex parte* presentation is not prohibited if specifically requested by the Commission or staff for the clarification or adduction of evidence or resolution of issues in the proceeding. However, any new written information elicited from such a request or any summary of any new information shall be served by the person making the presentation upon the other parties to the proceeding in a particular docket unless the Commission specifically waives this service requirement. Any comment which has not been served on the petitioner constitutes an *ex parte* presentation and shall not be considered in the proceeding. Any reply

## **APPENDIX**

- 1. Pursuant to authority found in 47 U.S.C. Sections 4(i), 5(c)(1), 303(g) and (r), and 307(b) of the Communications Act of 1934, as amended, and 47 C.F.R. Sections 0.61, 0.204(b) and 0.283, IT IS PROPOSED TO AMEND the DTV Table of Allotments, 47 C.F.R. Section 73.622(i), as set forth in the *Notice of Proposed Rule Making* to which this *Appendix* is attached.
- 2. Showings Required. Comments are invited on the proposal(s) discussed in the *Notice of Proposed Rule Making* to which this *Appendix* is attached. Proponent(s) will be expected to answer whatever questions are presented in initial comments. The proponent of a proposed allotment is also expected to file comments even if it only resubmits or incorporates by reference its former pleadings. It should also restate its present intention to apply for the channel if it is allotted and, if authorized, to build a station promptly. Failure to file may lead to denial of the request.
- 3. Cut-off protection. The following procedures will govern the consideration of the filings in this proceeding;
- (a) Counterproposals advanced in this proceeding itself will be considered, if advanced in initial comments, so that parties may comment on them in reply comments. They will not be considered if advanced in reply comments. (See Section 1.420(d) of the Commission's Rules.) Because the Commission has not yet lifted its freeze on the filing of petitions for rulemaking to establish new DTV channel allotments and for changes in community of license, <sup>10</sup> we will not consider counterproposals which propose new allotments or changes in community of license.
- (b) With respect to petitions for rule making which conflict with the proposal in this Notice, they will be considered as comments in the proceeding, and Public Notice to this effect will be given as long as they are filed before the date for filing initial comments herein. If they are filed later than that, they will not be considered in connection with the decision in this docket.
- (c) The filing of a counterproposal may lead the Commission to allot a different channel than was requested for any of the communities involved.
- 4. Comments and Reply Comments; service. Pursuant to applicable procedures set out in 47 C.F.R. Sections 1.415 and 1.420, interested parties may file comments and reply comments on or before the dates set forth in the *Notice of Proposed Rule Making* to which this *Appendix* is attached. All submissions by parties to this proceeding or by persons acting on behalf of such parties must be made in written comments, reply comments, or other appropriate pleadings. The person filing the comments shall serve comments on the petitioners. Reply comments shall be served on the person(s) who filed comments to which the reply is directed. A certificate of service shall accompany such comments and reply comments (*see* 47 C.F.R. Section 1.420(a), (b) and (c)). Comments should be filed with the Federal Communications Commission, Office of the Secretary, 445 12<sup>th</sup> Street, Room TW-A325, S.W., Washington, D.C. 20554.
  - 5. Number of Copies. In accordance with the provisions of 47 C.F.R. Section 1.420, an
